**Robert Randall.** Robert lives in Brunswick, Georgia, and has attended practically every NWTRCC meeting since its inception. He has also been a key organizer for the NWTRCC tabling at the School of the America's protest every November. He was dismayed that “Unfortunately, approximately ½ of federal income tax money, which goes into the U.S. general fund, gets spent in some way on past, present, or future war. Congress still has not, as it should have, supplied a way for religious conscientious objectors to pay taxes without violating our religious beliefs. I, and others like me, are therefore left with no alternative but to not pay, since I certainly cannot willingly disobey God.” Robert is seeking to recover **\$4884.14** in Penalties and Interest seized by the IRS for tax years 2007-2012. The IRS is currently seizing most of his wages for refused taxes.
