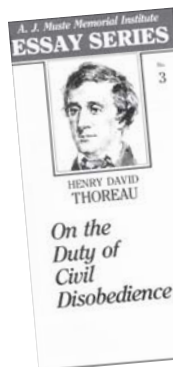

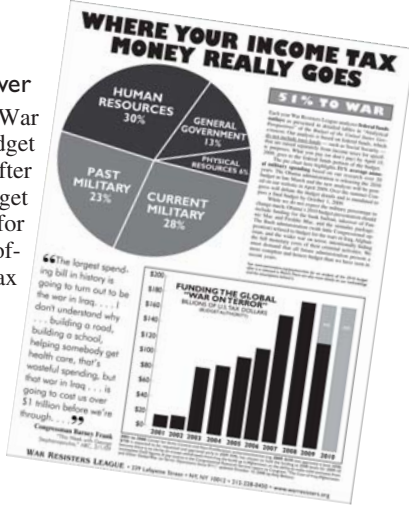
Answers to Common Questions Covers frequently asked questions. Designed for outreach in peace community to people who have heard of war tax resistance.

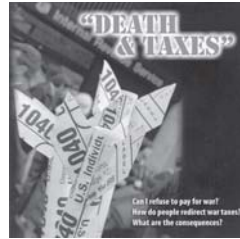
